All bids shall be accompanied by a ten (10%) percent bid guaranty, payable to the Valley Regional Fire and Rescue and an acceptable Agreement of Surety.

Bid security shall be in one of the following forms only: Certified check (drawn on a bank authorized to conduct business in the Commonwealth of Pennsylvania) or bid bond. Lack of bid guarantee may be cause for rejection of submitted bid.

A one-year Maintenance Bond shall also be required, for 10% of the final contract amount. The Maintenance Bond shall be required at the project closeout and shall be a part of the project closeout documents. Cost of all bonds is to be included in the Contractor's base bid.
